

- 2. The table of sponsorship components attached above is an inseparable part of this agreement.
- 3. The payment for the sponsorship will be transferred to the association via wire transfer, according to the following installments:
 - a. Gold and Platinum Sponsorships
 - i. Until January 31, 2025, 25% of the sponsorship amount will be transferred.
 - ii. By July 31, 2025, an additional 25% of the sponsorship amount will be transferred.
 - iii. By October 31, 2025, the remaining 50% of the sponsorship amount will be transferred.
- 4. The transfer of contents for publication to the members of the association by the sponsoring companies will be carried out in coordination with and through the committee of the association.
